Thank you for considering a donation to the Panhandle Pathway. Guidelines for Tax deductible donations follow.

The Friends of the of the Panhandle Pathway, Inc is a Non Profit organization organized for the purpose of developing, operating and maintaining the Panhandle Pathway. IRS tax exempt number: EIN 26-1214550, DLN 307296015, Indiana Tax TID: 0136455786. At this time the FoPP is organized as a 501c4 Non Profit organization. To assure that donations may be tax deductible by the donor, a relationship has been established between the FoPP and the Pulaski County Community Foundation (PCCF).

If you are not worried about the tax deduction please make your check out to: Friends of the Panhandle Pathway. A specific purpose can be included in the memo line if desired. Mail to FoPP, POBox 153, Winamac, IN 46996 or hand deliver to any member. These donations go into our Checking Account for day to day operational uses.

If you desire that your donation is valid for your tax deduction, make your donation to the Pulaski County Community Foundation, indicating that it is for the benefit of the Panhandle Pathway. You will receive a tax receipt from the PCCF for these donations.

Tax deductible general donations and donations toward sponsored items (less installation cost) are split between 2 funds: Operations (including maintenance) funds and long term Endowment funds.

-Operations funds are for near term day to day Operations and Maintenance, such as liability insurance, accounting, web site, information, trail- mowing, trimming, cleanup patching, repair etc.

-Long Term Endowment fund is designated for future long term Operations. Assuring that the trail is kept in good operational condition during its lifetime.
